
#### **NEW BUSINESS**

Friends in Christ,

We have been reading and hearing from Paul's powerful letter to the church in Corinth over the last month. Some biblical passages are so well known in the life of the church that it's hard to disassociate them from the ritual we're accustom to hearing them or to see them with fresh eyes. For example, it's hard to hear 1 Corinthians 13 without thinking of white dresses, suits, flowers, and all the other elements of a wedding. However, like any biblical text, it's important to understand the historical context. Paul's immortal words in 1 Corinthians arose out of a pastoral crisis in the Corinthian Church. The Corinthian Christians are abusing their freedom, refusing to share, scoring their neighbor's spiritual gifts, bragging about their own gifts and seeking recognition for themselves. Paul encourages the Corinthian Christians with a simple command: practice love. Paul speaks about the primary importance of love, the character of love, and the endurance of love.

Paul speaks about the character of love. This month we are bombarded with countless images and ideas of love. However it is helpful to remember that Paul is speaking about agape, the love embodied most visibly in God's love for human beings in the life, death, and resurrection of Jesus Christ. This love is not in the first instance a feeling, but an action. This love seeks not its own good, but the good of the one who is loved. There is


nothing sentimental about the image of love that Paul sets before the church. Paul is talking about a love that is active, tough, resilient, and long-suffering.

The love described in 1 Corinthians 13 is a love we experience as Christ's unwavering grasp upon our lives. Christ's love is the source of our greatest security and is the catalyst for our ability to be patient and kind, to bear all things and not insist on our own way. There is beautiful irony in the fact that the one thing that lasts forever is the love that is given away. Even though none of us can make sense of all our earthly experiences or see clearly what eternal life will be like, we can trust in Christ Jesus and his divine love experienced in human life and on the cross.

This month as we give and receive Valentines, may we also remember the greatest love ever given, the love of Christ. May our lives give testimony in word and deed to the reality of Christ's love in our lives as we serve and love one another.
